Key Responsibilities:

- Analyze and evaluate investment opportunities in the Significant Risk Transfer (SRT) asset class.
- Conduct fundamental sector, market, and security analysis across a broad array of SRT transaction types for potential investments across both primary and secondary markets.
- Develop detailed security level transaction analysis, present data to broader Investment Team and document research and recommendations in Investment Memo format.
- Monthly monitoring of existing positions through transaction reporting data, industry research and management / issuer discussions.
- Collaborate with Data Team on reporting, transaction details and reviewing of transaction output for transactions covered
- Conduct analysis to guide financing and currency hedging strategies on a transaction level basis.
- Communicate and collaborate with other members of the Investment team, including Portfolio Managers and Traders to help facilitate effective decision-making processes and present views concisely and effectively
- Manage relationships with Issuing Banks, be able to communicate effectively with senior members of Global Banks.
- Work closely with Teams in both London and Denver managing time zones and communication strategies of varied time zones
- Liaison with various external parties and internal departments, including Investments, Operations and Legal, throughout transaction execution.

Required Education / Certifications, Experience, Competencies & Skills:

- Bachelor's degree in finance, mathematics, business, science, engineering, or economics. Master's Degree or CFA progress is preferred.
- Three to seven years of modeling, analysis and or investment experience required in securitized credit (i.e. CLO/ABS/CRT) and experience in Significant Risk Transfer (SRT) transactions or Credit Risk Transfer (CRT).
- Experience in bank SRT or other first loss structured investments is preferred but not required.
- Ability to independently analyze transactions (portfolio analysis, structure analysis, documentation review) with a strong understanding of current market dynamics.
- Strong quantitative skills and the ability to communicate complex investment ideas in a manner that is easily understood.
- Strong analytical skills and experience using tools such as Bloomberg and Intex to create cash- flow models.



- Proficient in Microsoft Office (excel, word, outlook, etc.).
- Strong written and verbal communication skills.
- Collaborative, inquisitive and detail-oriented personality.
- Ability to work well in a team environment.
